Read Academy Remote Education – Contingency Plan (Parental Guide)



INTRODUCTION

We have not forgotten how challenging the period of remote teaching and learning was for our families, and the extraordinary lengths that our community went to ensure that the children of Read Academy continued to receive an excellent education.

As a school, we continue to be incredibly grateful to all our staff and families for everything that they did to keep momentum going through the most challenging of periods.

As we are back in school, we hope that we will not have to return to delivering our programme online; however, it is important to be ready for all eventualities and, as such, this Contingency Plan explains how the school will ensure a continuity of education in response to one of three scenarios where children may be required to learn from home. These are:

Level 1. In the event that a pupil or groups of pupils are required to self-isolate for a period of time due to a confirmed positive case or cases of COVID-19.

Level 2. In the event that an entire kingdom (bubble) is required to self-isolate for a period of time due to a confirmed positive case or cases of COVID-19.

Level 3. In the event of multiple COVID-19 cases within the school community or a local outbreak and the school is asked to close by a local health protection team or the local authority.

Having already run a successful and comprehensive remote teaching and learning programme, we are confident that - should the need to relaunch it be necessary - we could do so quickly and effectively. However, this said, there has been considerable reflection on our previous offer, which incorporated the valued feedback we have received from staff, children and parents.

Whilst this Contingency Plan provides insight into how the different aspects of school life will be translated into online provision, we will provide pupils with a **'Self-Isolation Learning Pack'** along with this document with more detailed and updated guidance at the time about the following:

- Remote Teaching and Learning
- Remote Care and Wellbeing

WHOLE SCHOOL OVERVIEW - LEVELS AND RESPONSES

Level 1

In the event that a pupil or a group of pupils are required to self-isolate for a period of time due to a confirmed positive case or cases of COVID-19.



Response 1

Individual home learning provided. (English, Maths, Topic & Islamic Education).

3-4 well-being sessions during period of self-isolation. (10 days)

Provide a designated Q&A time weekly.

Level 2

In the event that an entire kingdom (bubble) is required to self-isolate for a period of time due to a confirmed positive case or cases of COVID-19.



Response 2

Live lessons and following the daily timetable as closely as possible.

2 live well-being sessions during period of isolation. (10 days)

Level 3

In the event of multiple COVID-19 cases within the school community or a local outbreak and the school is asked to close by a local health protection team or the local authority.

Live lessons and following the daily timetable as closely as possible.

2 live well-being sessions during period of isolation. (10 days)
